Dr. Robert Stanley Wood, Vice President of Academic Affairs/Dean, Director of the Doctor of Ministry Program, Clara Scott Professor of Parish Ministry, and Editor of The Memphis Theological Seminary Journal joined the Memphis Theological Seminary community in July of 1998.

Prior to coming on board as an a faculty member and administrator, Dr. Wood served the seminary as an adjunct faculty member (1992-1997) and a Board of Trustees member (1971-1980; 1982-1989), serving two years as Moderator of the Board of Trustees.

He is an ordained minister in the Cumberland Presbyterian Church in America. He has served in ten pastorates since 1965. Since May 2011, he has been serving as the pastor of the Mt. Tabor Cumberland Presbyterian Church in America, Jackson, Tennessee.

Prior to his appointment at Memphis Theological Seminary, Dr. Wood was employed by the Cumberland Presbyterian Church in America as Director of Christian Education (1973-1979) and General Secretary/Stated Clerk (1979-1998), working in the denominational center in Huntsville, Alabama.
