Pursuant to the *Jeanne Clery Disclosure of Campus Security Policy and Campus Crime Statistics Act* also known as the Clery Act, the Seminary is required to compile and publish crime statistics in an Annual Security Report. As part of that obligation, members of the Seminary's community who are considered to be Campus Security Authorities (CSAs) are required to report crime statistics for inclusion in the Seminary's Report. The law defines "Campus Security Authority" as "An official of an institution who has significant responsibility for student and campus activities, including, but not limited to, student housing, student discipline and campus judicial proceedings." CSAs include, but are not limited to, faculty advisors to student organizations, police and security departments, personnel in the Dean of Students office, Student Housing office, and other officials who have a significant responsibility for student and campus activities.
