On behalf of the Department of Facilities and Safety, I extend you a sincere welcome and best wishes for your tenure with Memphis Theological Seminary.

At its heart, the Clery Act is a consumer protection law designed to keep current campus community members, prospective students, and employees well-informed and make institutions of higher education like MTS safer places. By the federal regulations of the Clery Act, Memphis Theological publishes crime and fire statistics for the three most recent calendar years and security-related policies and procedures.

Campus crime, arrest, and referral statistics include those reported to the MTS Department of Facilities and Safety, designated campus officials (including, but not limited to, directors, deans, department heads, advisors to students or student organizations), and local law enforcement agencies.

Each year, an e-mail notification is made to all enrolled students, faculty, and staff with a link that will take you to this report. Prospective students may obtain a paper copy of this report from Admissions located in the Brown Shannon Hall on the MTS campus or by calling 901-334-5870. Prospective employees may receive a hard copy from the President's office in Founder's Hall outside the President's Office or by calling 901-334-5870.
